## Upgrade Information for Document Management

---

You must install one or more of the following products before you install Document Management:

- Sage 300 Construction and Real Estate 12.1
- Sage Estimating 12.1

### Upgrade Path

You must upgrade to Document Management 9.7 or 9.8 in order to install 12.1.

If you are using a version earlier than 9.4, you must first upgrade to 9.4, then to 9.8, then to 12.1.

If you are upgrading from 9.4.1 or earlier, you must set up security in Desktop after you have installed 9.8, and BEFORE installing 12.1. See Chapter 6: Security in the Document Management *User's Guide* before you begin the upgrade process.

If you are upgrading from 9.5 or 9.6, you must install 9.8 before installing 12.1. You should already have set up Document Management security.

Before you install Document Management, check with your business partner to ensure you have the latest updates of Sage 300 Construction and Real Estate.

### New Activation Code Required

---

Due to major enhancements to the DocuVault and Document Management, a new activation code is required for installing 9.6.1 or later. Without the new activation code, you cannot complete the installation. You will have received an order confirmation for the upgrade which contains a new activation code number (also called activation key) for use with Document Management 9.6.1 or later.

# New in This Release

## Subcontractor Compliance

---

Two new document classifications (**Certified Reports** and **Misc. Compliance**) are now available on existing compliance types Lien Waiver and Insurance. From the **Subcontractor Compliance Management** hub in Accounts Payable and Project Management, you can quickly and easily query these document types based on the filter criteria you have selected.

---

**Note:** Insurance documents can be queried by vendor only, because "Job" is not an existing index for this document type.

## Routing approved by name

---

Routing approved by name has been added to approved stamp. In 12.1, when a routed document is approved, the approver name is added to the approved stamp.

# Known Issues

## **AP Invoice Batches Locked During Accounting Install**

During the Accounting installation, AP invoice batches that are in the Document Management Scan queue will be locked. These batches are then automatically moved from the Scan queue to DocuVault during the installation of DocuVault 12.1. If you want to send these batches to an Inbox prior to the upgrade, you must complete that action before installing Sage 300 Construction and Real Estate.

## **RAM Limitation on Computers with DocuVault**

You can not install more than 64G of RAM on a computer where DocuVault is installed. See [Knowledgebase article KB533995](#) for more information.

## **Avoid Installing IIS on a Domain Controller**

Document Management and DocuVault require that Internet Information Service (IIS) be installed and active on the DocuVault and Accounting servers if they are separate.

For security and performance reasons, [Microsoft recommends that you avoid installing IIS on a domain controller](#). Domain controllers that include IIS, such as Windows Small Business Servers, may require custom configuration to work with DV and DM.

To avoid these issues, we recommend that you do not install DocuVault or Document Management on a Windows Small Business Server or domain controller.

# Fixes

## **Classifying Multiple AP pages**

Previously, only first page of a multiple page document was indexed by the DocuVault. The system now indexes all pages the document. You can now view all pages of a document when you run a DM query.

## **Concurrent license count error**

The system now prompts you if you run out of concurrent licenses.

## **Batches in Scan Queue Caused Performance Issue**

Previously, batches remained in the Scan queue instead of sending to the DocuVault. This caused performance issues.

In 12.1, when you link an AP invoice batch, you will receive a prompt asking what you want to do with this batch. You can select to release to DocuVault directly, send to Inbox, or edit or route. You should experience better performance when processing AP invoice documents.

## **Document Type Security**

Document type security was reset when sending to DocuVault. This has been fixed.

## **Accounts Payable and Document Management Data**

AP invoice documents are now updated with the most current data from Accounts Payable.

## **Detail Window Displayed Incorrectly**

Previously, when you opened a document that has been classified as an AP invoice, but contained no detail information, the Detail window displayed incorrectly. This has been resolved.
