Workstation Synchronization has been enhanced to update Sage 100 Standard Workstations along with Sage 100 Advanced and Premium Workstations. Sage 100 Standard Users are no longer required to run WksUpdate Standard.exe on each Sage 100 Standard Workstation.

Sage 100 Payroll must be installed from the server where Sage 100 is installed.

- 2. In Employee Maintenance on the Taxes tab:

a. For the state of Colorado (Tax Code=CO), select Filing Status = 01 (CO DR 0004 Form 2022 or later)

b. In the Annual WH Allowance field, enter the dollar amount from Line 2 of the employee's form.

c. In the Additional Tax field, select Add an Amount

d. In the Additional Amt field, enter the dollar amount from Line 3 of the employee's form. DevID 113380
