Software requirements

To use this product update, you must have Sage 300 Canadian Payroll 7.3, which is supported in Sage 300 2023, 2022, 2021, and 2020.

Upcoming requirements

In the upcoming release of Sage 300 2024 this September, there will be a new version of Payroll, 8.0. The tax tables for Payroll 7.3 will be available until March 2024. After this date, tax tables and support will only be available for Payroll 8.0.

Note: If you are using an older version of Sage 300, please reach out to your Business Partner for your upgrade options.

Provincial and Territorial Legislative Updates

This section lists provincial and territorial legislative updates available with this release. If a province and territory is not listed in this section, there are currently no tax updates or product modifications for that province and territory. Manitoba

Manitoba has increased the basic personal amount from \$10,855 to \$15,000 for 2023. Since the previous amount has been used for employees for the first six months of this year, use a prorated basic personal amount of \$19,145 for the remaining six months commencing with the first payroll in July.

Québec

Quebec has decreased the rates for the first two brackets by one percent. For more information, contact your tax services office or visit the government website.

Payroll product updates

The following new features and improvements to payroll are included with this update.

Fix for Data Activation

We have fixed a problem that occurred after activating payroll tax updates which caused an internal error to appear after activation completed.

Fix for deleting terminated employees

We have fixed a problem that occurred when running Delete Terminated Employees in Periodic Processing, Delete Inactive Records that prevented terminated employees from being deleted successfully.

Fix for Royal Bank EFT bank format

We have fixed a problem that generated an incorrect EFT file when using the Bank Format Royal Bank - New.

Fix for printing datapipe reports in Sage 2023 PU3

We have fixed a problem that prevented datapipe reports, such as Payroll Register and Earnings and Hours, from printing in Sage 300 2023 PU3.

Product update installation instructions

Follow the instructions in this section to install, apply, and verify this Product Update.

Before you start:

- Back up your data.
- Make sure all users have exited the program.
- Verify your service pack or product update level. To verify what service pack or product update you have installed, click the System Information option on the Help menu in Sage 300.

Installing the product update

To install the product update:

- 1. Right-click the Product Update file to Run as Administrator (or make sure you have administrator rights to run the installation) and launch the installation program.
- On the Welcome window, click **Next** to continue to the Software License Agreement window.
- 3. Select the features to install. Click **Next**, then **Install**.
- 4. On the Setup Complete window, click **Finish** to finish the installation.

Activating the tax update

To activate the tax update:

- Start Sage 300.
- In the Administrative Services folder, select Data Activation.
- 3. Select the current tax update, and then click **Activate**.
- If you are prompted to convert a previous payroll tax update to the current version, click Proceed.

After you complete installation and activation, and after you have made any adjustments described in this document, you can resume processing payroll.

Verifying the product update

After the update is complete, you can confirm that the update was installed successfully by selecting **Help > System Information**.
