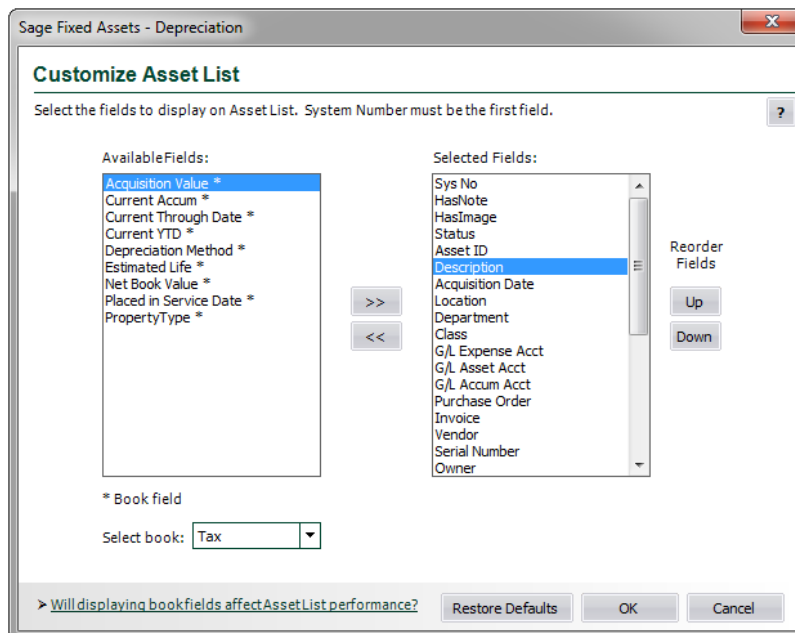
# Features

## Customize the Asset List

With the new Customize Asset List window (**Customize > Asset List**), you select the fields you want displayed on Asset List. You can display up to nine book fields for all the assets on Asset List. In addition, you can easily remove and reorder fields that are displayed.



## **Installation improvements**

The Sage Fixed Assets installation process now includes all Sage Fixed Assets products; Depreciation, Tracking, and Planning. This expedites the installation process for companies that purchase multiple products. Each unpurchased product comes with a free 30-day trial period, which allows you to open and explore them as desired.

## **Sage Advisor Update**

After installing this release (2017.0), all Sage Fixed Assets products listed in the above table will include Sage Advisor Update. Sage Advisor Update is a program that recognizes your installed products and notifies you of available releases. This feature makes it easier than ever to keep your products current—simply download the latest release from Sage Advisor Update when notified.

## Transfer report

Now you can choose your own custom date ranges for the Transfer report. Based on the **From** and **To** dates you enter, the Transfer report will display the transfers that occurred during the given date range.

## Submit or view product ideas

You can now import depreciation transactions from Sage Fixed Assets to Sage 100 Premium without editing the export file.

You will no longer see the following reviews when running Audit Advisor in a U.S. company because they are irrelevant:

- Transfers with 168 Allowance in Placed-In-Service (PIS) Year (only in Sage Fixed Assets Depreciation)
- Light Trucks and Vans
- Increased 168 Allowance %

# Fixes

With this release, Sage made the following fixes to Sage Fixed Assets Depreciation (Premier, Network and Standard), Sage Fixed Assets Lite Depreciation, Sage Fixed Assets Lite Depreciation for Sage 50, and Sage 50 Fixed Assets.

## Ghost connections

Sage added a two-minute timeout check to Sage Fixed Assets\Network to fix the issue where a user connection may have remained open, even though the user was not in the program.

## Company list

Sage has improved the loading performance of the company list from the Backup Company and Restore Company dialog boxes for databases with very large numbers of companies (i.e. 8,000+).

## Reports

### PDF column headings

Report headers are now readable when you print to PDF on a Citrix® network.

### Global Task Manager

Sage Fixed Assets Depreciation (Premier) now prints reports directly to a printer from Global Task Manager if you are using a Citrix® network.

### Depreciation Expense report (Premier only)

The Depreciation Expense report is no longer missing data when you configure it to use **Other Date** through the Global Task Manager.

## Sage 300, Sage 300 CRE, Sage 100 and SFA Depreciation with custom Crystal Reports

Sage Fixed Assets custom reports can now be opened from the Reports menu and from Report Writer.
