






SAP® Crystal Reports Designer 2020

Sage Fixed Assets Scanner v2.2*

The <u>Sage Fixed Assets Scanner app</u> for Android has been updated to include security and reliability improvements. It will be available in the Google Play Store in September 2023.



Defect Fixes

With this release, Sage made the following defect fixes to the indicated Sage Fixed Assets products. Fixes with no specific product notation apply to all products that include the feature.

Leading zeros drop on Custom Import

Fixed an issue that caused leading zeros in .csv files to be dropped during Custom Import. Leading zeros are now retained and properly imported.

Incorrect 168 expense on tax forms when using certain asset Groups

Fixed an issue that could cause incorrect 168 expense amounts on tax forms. This problem occurred when running the form for an asset Group with the "Contains" operator and a numeric "Find What" value.

Sage Intacct Link: All groups don't display in Group drop-down list

Canadian and Government or Nonprofit Organizations

Fixed an issue where only the "All Complete Assets" and "All Incomplete Assets" groups appeared in the Group drop-down list of the Sage Intacct window, used for posting Depreciation expense. Now all groups in the selected organization display.

Known Issues

Crystal Reports compatibility

Sage Fixed Assets 2024.0 uses SAP Crystal Reports runtime SP30. This may cause an issue with older Crystal Reports runtime versions that other products use.

You may experience a compatibility issue after upgrading to Sage Fixed Assets 2024.0 if you later install (or reinstall) Sage 500 on the same machine.

Resolution

If you cannot run reports in Sage Fixed Assets 2024.0 after installing Sage 500, review <u>Knowledgebase article</u> <u>221924660118149</u> for steps to resolve the issue.

Preparing mobile readers after upgrade

Sage Fixed Assets—Tracking (all versions)

After upgrading to Sage Fixed Assets 2024.0 from 2023.1, the Prepare button in the Prepare Reader window may not respond.

Resolution

If you cannot prepare a mobile reader after upgrading to Sage Fixed Assets 2024.0, review <u>Knowledgebase</u> <u>article 230913154529690</u> for steps to resolve the issue.
